The participant, by executing his or her signature to this release, does hereby release, waive, discharge and covenant not to sue Golden Door Institute, LLP, its owners, officers, employees, volunteers, promoters, contractors or business partners from any and all liability, injuries, or any other claims and damages, as a result of participating in an event sponsored by Golden Door Institute, LLP.

Furthermore, the participant, on behalf of his personal representatives, assigns, heirs and next of kin does hereby release any and all claims, damages, injuries incurred by the participant in regards to the participation of such events. Participants agree to hereby release any and all claims of whatever kind of nature, present and future, damages and injuries.

Participant assumes full responsibility for and risk of bodily injury, death, or property damage due to negligence or non negligence of Golden Door Institute, LLP, its owners, employees, volunteers, promoters, contractors.

The undersigned further acknowledges that he/she is voluntarily participating despite risk of falls, contact and/or collisions with other participants, defective equipment, and the condition of the room.

Participant in consideration of being permitted to participate in the escape room event acknowledges the risks and hazards involved in and arising from attending, participating in, or as a spectator or bystander, of any escape room experience/event including but not limited to the additional risks of experiencing mental stress and anxiety, seeing disturbing images and content including but not limited to being exposed to learning about violent acts, being hit with flying or falling objects, falling, and does for himself or herself, his or her heirs, executors, administrators, and assigns, release and forever discharge Golden Door Institute, LLP, their contractors and actors, of and from any and every claim, demand, action or right of action, of whatsoever kind or nature, either in law or in equity arising from or by reason of any bodily injury or personal injuries known or unknown, death and / or property damage resulting or to result from any accident which may occur as a result of participation in the escape room experiences or any activities in connection with Golden Door Institute, LLP, whether by negligence or non negligence of from any all other incidents of harm and/or ill-will. Participant agrees and understand that all staff may, in their sole discretion, determine it is unsafe for myself or others to participate or continue participating and may, by any lawful means, remove me from the premises.

I comprehend the risks involved with participating as a spectator or participant. I assume all risk associated with participating in the escape room including paralysis and death caused by course and contact with other participants or actors. I agree and understand Golden Door Institute, LLC, is not held responsible for any lost or stolen items left in my vehicle or in the facility. I agree that Golden Door Institute, LLP, or any of its assigns has the right to any photographs or any video/sound footage of me during the escape room event. These photos, video footage and sound materials may be used for any marketing purposes. I fully understand that there are no refunds under any conditions once I purchase my entrance fee.

I agree and understand the possibility of failure to escape the room in the allotted time. I agree and understand I CANNOT disclose or share any information regarding how to solve or put together puzzles, unlock props, share where puzzles can be found, give "spoilers" nor discuss how to escape on any social media platform of any kind of the rooms provided by Golden Door Institute, LLC.

When registering online, my online signature shall substitute for and have the same legal effect as if I had signed a waiver and release agreement.
